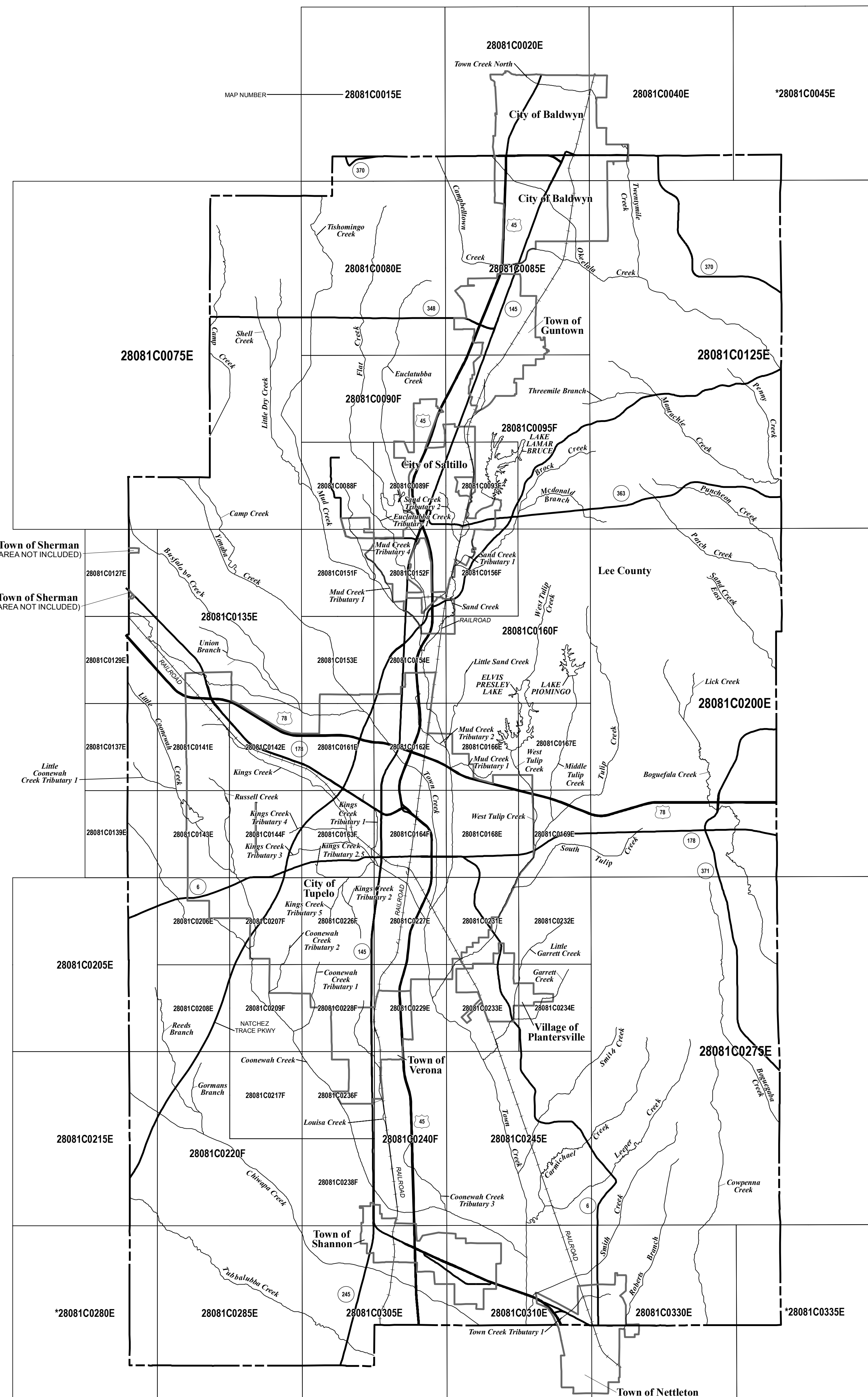


NOTE TO USER

Approved requests for changes will be shown on the final printed FIRM.

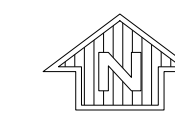
