For community and countywide map dates refer to the Flood Insurance Study report for this jurisdiction.



Orthomage was originally produced by Fugro Earthdata in 2006 and has a 2-foot pixel resolution. Supplemental imagery was produced by National Agriculture Imagery Program (NAIP) in 2016 and has a 0.6-meter ground sample distance. 
